By examining works such as Omprakash Valmiki's "Joothan," Alex Haley's "The Autobiography of Malcolm X," and Richard Wright's "Black Boy," the study analyzes the social, economic, and psychological impacts of systemic oppression. It investigates how autobiographical writing contributes to identity formation and resistance among marginalized communities. Key findings reveal significant similarities in the experiences of humiliation and economic exploitation faced by both Dalits and African Americans, highlighting the universal nature of systemic oppression. However, distinct historical and cultural contexts—caste-based discrimination in India and racial segregation in the U.S.—shape unique manifestations of injustice.
