- 2. Participation in Politics: The 73rd and 74th Amendments to the Indian Constitution introduced a 33% reservation for women in local government bodies. Women leaders in states like Kerala and West Bengal have shown that empowering women leads to better governance and development outcomes.
- 3. Empowerment through Technology: Programs like Digital Sakhi provide digital literacy training to rural women, helping them access government schemes, market their products, and connect with wider networks. - 4. Government Schemes: "Ladaki Bahan Yojana" is a Maharashtra government scheme .aimed at the welfare and empowerment of women. Through this scheme, women are given 1500 rupees every month.

IV. POLITICAL EMPOWERMENT OF WOMEN

The 73rd Constitutional Amendment Act of 1992 introduced a mandatory 33% reservation for women in rural local bodies like Panchayats, allowing them to take on leadership roles such as sarpanches. This change significantly increased women's participation in local governance. In states like Kerala and West Bengal, similar reservations have been implemented in urban local bodies. At the national level, The Constitution (106th Amendment) Act, 2023, reserves one-third of all seats for women in Lok Sabha, State legislative assemblies, and the Legislative Assembly of the National Capital Territory of Delhi, including those reserved for SCs and STs. It was passed in September 2023 and aims to increase the representation of women in the Legislature. The reservation will be effective after the publication of the census conducted following the Act's commencement and endures for a 15-year period, with potential extension determined by parliamentary action. The rotation of seats allocated for women will be governed by parliamentary legislation after each delimitation process. Prominent women leaders such as Indira Gandhi, Sonia Gandhi, and Mayawati have set strong examples by holding significant political offices. Additionally, self-help groups (SHGs) and NGOs have played a crucial role in educating women about their political rights and encouraging their participation in elections and decision-making processes. These efforts, along with continuous advocacy for policy changes, are helping to break down barriers and empower more women in Indian politics.

V. ECONOMIC EMPOWERMENT OF WOMEN

Women's economic empowerment in India has been progressing, although challenges remain. Initiatives like the National Rural Livelihoods Mission (NRLM) and various self-help groups (SHGs) have been crucial in improving women's access to economic opportunities.
